QUALITY QG-1 LIMITED WARRANTY

General Warranty Information

Quality Glass warrants its Quality QG-1 insulated Glass units to the original purchaser for a period of ten years from date of manufacture. Insulated units will be free from material obstruction of vision as a result of dust or film formation on the interior surfaces caused by flaws in the hermetic seal due to faulty manufacturing.

Quality Glass accepts no responsibility for failure of the Quality QG-1 insulated glass product due to faulty installation or building construction, design or glass breakage, improper usage, or alteration of original product. Alteration of product includes, but is not limited to, the application of film or tint. We also will not take responsibility for slope glazing, solar collectors, swimming pool and whirlpool enclosures; or if the unit is subject to excessive temperature difference over the surface of the glass and glass edge; and if interior shading device (including but not limited to: blinds, draperies and roller shades) installion is closer than two inches (2") to the interior lite, otherwise improperly installed per industry standards. Proper installation must allow for expansion and contraction of framing members and for proper stop coverage so the sealants are not exposed to ultra-violet rays, moisture, and foreign matter.

In the event the said product fails, Quality Glass will furnish the purchaser with another product F.O.B. Quality Glass manufacturing plant, or refund the original purchase price paid to Quality Glass. Quality Glass will cover no other expenses such as labor or any other cost that the purchaser might have incurred due to the failure. In the event Quality Glass elects to supply another product, the warranty period shall not be extended.

Quality Glass warrants that the goods, which it has supplied, will be fit for the particular purposes of use expressed by the buyer. This express warranty excludes all implied warranties. There are no other express warranties and no other warranties that extend beyond the description given by this limited warranty. The liability of Quality Glass under this warranty, in negligence or otherwise, under no circumstances shall include special, indirect or consequential damages. The price paid is consideration in limiting the liability of Quality Glass. No action, regardless of form, arising out of the transactions under this limited warranty may be brought by buyer more than one year after the cause of action has occurred. Quality Glass will cover no other express including, but not limited to, labor of any other cost that the buyer may have incurred due to any failure of the Quality QG-1 units.

This limited warranty is delivered and accepted in the State of Nebraska; in the event of alleged breach of any covenants herein, regardless of the site of the property involved or the place of the alleged breach, this warranty shall be interpreted and enforced in accordance with the laws of the State of Nebraska and must be filed in the courts of the State of Nebraska.
